the **Minister for Home Affairs, Security, Reforms and Equality** to

- urge the Commissioner of Police, Commissioner of the National Commission for the Promotion of Equality and Victim Support Agency and along with

the **Minister for Social Policy and Children's Rights** to

- urge the Commissioner for Children, Council for Children, Foundation for Social Welfare Services, Child Protection Services, Appogg and the Fostering Board to further Parental Alienation awareness, detection and intervention, to provide more gender-neutral services
